He should have experience of 15 years in Civil Engineering Works & 5 years in execution / quality control of Road and Bridge works under Central Govt. / State Govt. / Public Sector undertaking of Central or State Govt. / Highway Lab of Engineering Colleges approved by AICTE for engagement as "State Quality Monitor" to inspect PMGSY Works of different PIUs (Project Implementation Unit) of Odisha.
