



He should have experience of 15 years in Civil Engineering Works & 5 years in execution / quality control of Road and Bridge works under Central Govt. / State Govt. / Public Sector undertaking of Central or State Govt. / Highway Lab of Engineering Colleges approved by AICTE for engagement as "State Quality Monitor" to inspect PMGSY Works of different PIUs (Project Implementation Unit) of Odisha. Preference will be given to retired Engineer-in-Chief / Chief Engineer / Superintending Engineer / Executive Engineer of Works Department and faculty of Transportation Engineering of Technical Institutions.
