## **TENDER CALL NOTICE**

Sealed quotation/tenders are invited from interested reputed Travel Agencies/Tour Operators or private individuals for providing one number of Non AC Diesel driven vehicles having sitting capacity not more than ten including driver, which shall confirm to the terms & conditions (Annexure-I, II & III) for official use in Rural Development Department on monthly rent basis:

- 1. The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- 2. The driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 3. The driver should be well behaved, gentle and obedient in nature.
- 4. A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the Under Secy. to Govt., RD Deptt. and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 5. The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel & lubricants)
- 6. The Vehicle must achieve a fuel efficiency of 17 Kms per litre.
- 7. The details of the make & year of manufacture of the vehicle, registration No., mileage (Kms covered per liter) & name of the Driver with Driving License No. & period of validity should be specifically provided in the general bid information to be furnished with Quotation/Tender (Annexure-III)

- 8. The Quotation completed in all respect should reach the undersigned on or before 16.04.2016 by 4.00 p.m. & shall be opened on the same day at 5 p.m. in presence of bidders or their authorized representatives.
