Expression of interest is invited from interested individuals having graduate degree in Civil Engineering from a recognized University & retired from the post not below the level of Executive Engineer or equivalent from a State / Central Govt. Departments, Central / State Public Sector Undertakings (PSUs) or their subordinate offices. Retired / serving faculty members of Government Engineering Colleges/ IITs/ NITs/ Government Research Institutes, etc. who have worked / consulted in the field of road construction, associated with bridge design and supervision consultancy work can also apply.

- (i) **For inspection of Road/Bridge/Building Projects** – The candidate (retired Government Engineer) should possess the experience of working in the field of construction of roads/bridge/building for at least 5 years in last 10 years before his retirement from Central / State Government service. Also, in the last 5 years, he should have worked at least for 2 years in the field of road (any field out of planning and designing, execution or management of construction or maintenance of road). Retired/Serving faculty members of Government Engineering Colleges/ IITs/ NITs/ Government Research Institutes, should possess minimum 10 years' experience in the field of planning/ design/ supervision/ execution/ consultancy of construction and maintenance of roads/bridges.
- (ii) **Recommending Authority** – The candidate (retired Government Engineer and retired / serving faculty members) should have been recommended by the concerned State Government or by Government of India organizations, administrative head of the PSUs or head of the Institute (as applicable), clearly indicating that his integrity is not questionable (Annexure -I(a) / I(b)).
- (iii) The candidate should be willing to work as Quality Monitor with high ethical standards and also submit the signed code of conduct (Annexure -II). Signature should be made on each page.
- (iv) Interested Engineers / Faculty Members should have sound health & physically fit to undertake tours to different rural pockets of any district and the applicant should not have attained the age of 67 years on the last date of application. The applicant would be allowed to work as QM till the attainment of 70 years of age.
- (v) The candidate who are retiring from the service on or before **Dtd. 31.03.2026** can also apply.
- (vi) The candidate should have working knowledge of computer and smart phones.

They may be required to inspect at least 5 days of inspection in each month depending on situation for the purpose of 2nd tier quality monitoring system, also upload their inspection reports and digital photographs taken during the inspection in the web portal, i.e., WAMIS and to submit the physical reports to Division as well as to QC cell at E.I.C. Office. Remunerations as per existing PMGSY norms will be paid. The period of empanelment will be one year which may be suitably extended in future. This empanelment is purely temporary and can be terminated if any misconduct found in future.

**Code of Conduct for Quality Monitors (QMs), Engaged by Govt. of Odisha, R.D. Department**

**Introduction**

The purpose of Code of Conduct is to ensure an ethical conduct in the Second-Tier inspection of works under State funded & Deposit works.

Under the Second tier of quality management mechanism operational for the inspection of State funded & Deposit works by Quality Monitors (QMs) is an independent assessment of quality of works executed under different schemes. The Main objective of second tier is to assist the Executing Agency in ensuring the quality of work by periodic inspection at defined stages of construction. The quality management mechanism of QM is to independently verify that the quality of Road or Building or Bridge works, executed confirms to the prescribed Standards and to see whether the prescribed quality management mechanism in the Rural Works organization is effective. The role of Second tier is also to provide guidance to the implementation machinery and the field engineers rather than '**fault finding**', as such; the basic duty of the QM is to inspect the Road/Building/Bridge works as per the guidelines prescribed by Govt. of Odisha, R.D. Department and prepare inspection report giving clearly his findings and suggestions for improvement. High ethical conduct is expected of the person who is engaged as Quality Monitor (State funded & Deposit) works.

It is important to structure the Independent Quality Monitoring in such a way that actual field realities are brought out, however, it is more important to ensure that the independent monitors carry out inspections properly and report truthfully.

A code of conduct is necessary and appropriate for the Quality Monitors because of the trust placed in the independent quality management system. The Code of Conduct extends beyond the definition of independent quality monitoring to include two essential components:

1. Principles that are relevant to the profession and practice of independent quality monitoring of road/building/bridge works.
2. Rules of Conduct that describe behavioral norms expected of Independent Quality Monitors. These rules are an aid to interpreting the principles into practical applications and are intended to guide the ethical conduct of Quality Monitors.

**Applicability**

This Code of Conduct applies to provide independent quality monitoring services under State funded & Deposit works.

✓ **Principles**

Quality Monitors are expected to apply and uphold the following principles:

✓ **Integrity**

The integrity of Quality Monitors establishes trust and thus provides the basis for reliance on their judgment.

✓ **Objectivity**

Quality Monitors exhibit the highest level of professional objectivity in gathering, evaluating and communicating information about the activity or process being examined. Quality Monitors make a balanced assessment of all the relevant circumstances and are not unduly influenced by their own interests or by others in forming judgments.

✓ **Confidentiality**

Quality Monitors respect the value and ownership of information they receive and do not disclose information without appropriate authority unless there is a legal or professional obligation to do so.

✓ **Competency**

Quality Monitors apply the knowledge, skills and experience needed in the performance of independent quality monitoring services.

**Rules of Conduct**

**1. Integrity**

Quality Monitors:

- 1.1. Shall perform their work with honesty, diligence and responsibility.
- 1.2. Shall observe the law and make disclosures expected by the law and the profession.
- 1.3. Shall not knowingly be a party to any illegal activity or engage in an act that brings discredit to the profession or to the organization for which the QM is working.
- 1.4. Shall respect and contribute to the legitimate and ethical objectives of the organization for which QM is working.
- 1.5. Shall not take Spouse/Close relations during inspection visits.

## **2. Objectivity**

Quality Monitors:

- 2.1. Shall not participate in any activity or relationship that may impair or be presumed to impair their unbiased assessment. This participation includes those activities or relationships that may be in conflict with the interests of the organization and the programme for which the QM is working.
- 2.2 Shall not accept anything that may impair or be presumed to impair their professional judgment.
- 2.3 Shall disclose all material facts known to them that, if not disclosed, may distort the reporting of activities under review.
- 2.4 Shall endeavour in guiding the executing machinery on correct technical procedures in Rural Road, Building & Bridge works.

## **3. Confidentiality**

Quality Monitors:

- 3.1 Shall be prudent in the use and protection of information acquired in the course of their duties.
- 3.2 Shall not use information for any personal gain or in any manner that would be contrary to the law or detrimental to the legitimate and ethical objectives of the organization or the programme for which the QM is working.

## **4. Competency**

Quality Monitors:

- 4.1. Shall perform independent quality monitoring in accordance with the Guidelines issued from time to time by Govt. of Odisha, R.D. Department for second tier quality monitoring.
- 4.2 Shall continually improve their proficiency and the effectiveness and quality of their services.

The upper age limit for working as QM shall be up to the age of 70 years subject to satisfactory performance and good conduct.

**Acceptance of above Code of Conduct by Quality Monitor (QM)**

I am aware that as QM, I may be assigned the duty for inspection of State funded & Deposit projects within the State and I will abide by it. I am also aware that empanelment as QM not necessarily means that I shall be assigned duty every month.

As QM, I will attend assignment of inspection within three months of successfully attending the Orientation-cum-training programme.
